When does IP-6 INTERNATIONAL, INC. collect information and how is it used?

When you enter information and when you use the site, IP-6 INTERNATIONAL, INC. gathers information in several ways to help us provide our services. These include registration, order history, site-usage patterns, cookie technology, and IP addresses.

Cookies

We may use cookies to store and track your preferences to provide you with a more personalized service. A cookie is a message sent to your browser from a Web server and stored on your computers hard drive. Most Internet sites use cookies. You can set your browser to reject all cookies. This will, however, prevent you from using some IP-6 INTERNATIONAL, INC. customized services, and you may have to re-enter personal information to participate in some services. Cookies make your experience easier by saving your preferences and passwords. We also use cookies that contain no personal information at all. These cookies help us estimate our audience size and determine which areas of the IP-6 INTERNATIONAL, INC. website are the most popular. No advertiser's cookie is ever placed on your computer by IP-6 INTERNATIONAL, INC. IP Address

We may log IP addresses for system administration or to report information in aggregate to our partners. An IP address is a number assigned to your computer automatically when you use the Internet. With whom does IP-6 INTERNATIONAL, INC. share information?

In general, we will not disclose your personal information to third parties, except to the extent necessary to provide you with a requested service or under circumstances required by law. However, aggregate data is not traceable to you specifically.

How can I limit the use of my personal information?

Most browsers can be set to alert you when a cookie is sent or prevent cookies completely. Residual information may remain in our archives as well as records necessary for billing history if you made purchases, but this information will not be used for a commercial purpose..
